- 1. Any legitimate Ice Hockey club/ Inline Hockey club in Hong Kong which admit the Hong Kong, China Ice Hockey Association Limited ("the Association") as the only official Association in Hong Kong and is willing to abide by the Constitution of the Association, observe its resolutions, disciplinary codes and membership fee payment schedule.
- 2. Applicant for registered club with the Association should truthfully fill in this form for approval. This application form should be filled in with accurate information in neat print while applicants are reminded to peruse these notes and the Constitution of the Association carefully. The Association will not accept the application unless the form is duly completed and the membership fee is duly received.
- 3. The applicant must provide together with the club's constitution/ company's constitution, name list of committee members (including chairperson/president, hon. Secretary, treasurer and all executive committee members/share holders/directors) during club registration. The Association will not accept the application unless the required information is duly received.
- 4. Club member list must be provided to the Association, the list must include member names (names can be replaced by numbers), date of births and sexes.
- 5. Under Constitutions of the International Ice Hockey Federation, no registered club of the Association shall in the meantime enroll as club member of other organizations (i.e. other Ice Hockey organizations) of similar nature nor can he/she take part in activities thereof. The Association reserves the right to stop or cancel the registration of the club if the registered club participating activities of organizations other than the Association without the prior consent from the Association.
- 6. All registered club of the Association should observe the laws of Hong Kong, abide by social morality and by all means preserve the goodwill of the Association through solidarity, mutual assistance, encouragement and advancement. Responsibilities for any incidents or violation of law shall be borne by the club whereas the Association shall be exempted from whatsoever liabilities. The Association has the absolute right to terminate the registration of any registered club which has committed wrongdoing without having to render any reasons or explanations thereto.
- 7. Any ice hockey events or competitions organized by the registered club with "Hong Kong" heading must be subject to the Association's prior approval at least 3 months before the events or competitions been held. No ice hockey events or competitions can be organized by the registered club with "Hong Kong" heading without prior approval by the Association.
- 8. All registered club of the Association have no rights to use either Hong Kong Flag or Emblem in any of their promotional tools and jerseys without sanction by the Association.
- 9. Members should pay attention to personal safety and self-insured when taking part in any activities organized by the Association. Incidents occurred or injuries inflicted shall be the responsibilities of the parties involved whereas the Association and its affiliated Associations shall not held responsibility for whatsoever liabilities, legal or economic loss, arising therefrom.
- 10.Applicant for registered club must have hockey development programs for either U-18 or Women division, or both.
- 11. The Association reserves the absolute right to refuse any application without giving any reasons or explanations thereto.
